

**Eaglestone Group announces appointment of Sophie Lambrighs  
as CEO of its Belgian subsidiary.**



Two years after joining the Group as COO (Chief Operating Officer) in charge of operational management and development of the project portfolio, Sophie Lambrighs has now been appointed as CEO of Eaglestone Belgium. She will pursue and contribute to forging the ambitious growth plan for the Group's development and investment business segments.

Sophie has a solid academic background (Construction Civil Engineer, MSc in Management) as well as over 20 years' professional experience as CEO for reference groups, including Axa, Immobel and Home Invest Belgium. She has also held the position of director at Retail Estates, Immobel and Ceusters.

Her appointment comes at a key stage in the growth of the European Group, which currently employs 80 people across the Group's entities in Belgium, Luxembourg and France.

In fact, Eaglestone Group, where Nicolas Orts and Gaétan Clermont will both continue as CEOs and shareholders, has experienced strong growth over the last 5 years and is today one of the leading market players.

This is due to the sustained growth both in Belgium and Luxembourg, but also to the Group's expansion in France with the acquisition last spring of the Interconstruction real estate development group. We also welcome Bois Sauvage as a new shareholder, alongside our historical shareholders, who will help implement our growth strategy, which aims to double the Group's EBITDA within 5 years.

In 2020, Eaglestone Group recorded an EBITDA of €45.6m.
